# What is American InfoSource and what data does it provide?

American InfoSource (AIS) is a commercial global financial services company that provides obituary and probate death data. AIS Death Data includes information about deceased individuals from all 50 states. AIS gathers information from probate court records and published obituaries. Obituaries are obtained by AIS from over 3,000 funeral homes and thousands of newspapers; probate records are collected from the county courts.

### What is the benefit of having an additional death data source?

The primary benefit to DNP users is that AIS provides additional death matches that might not be included in the Social Security Administration's Death Master File (DMF) - Public, which could allow earlier identification of ineligible payments. Also, additional matches for the same payment will give further insight for follow-up.

## How do I gain access to the AIS Death Data?

Payments submitted to DNP via the Payment Automation Manager (PAM) are automatically vetted against the AIS Death Data. AIS Death Data is available to all users in Payments, but requires onboarding for Online Search, Batch Matching, Continuous Monitoring, and Application Programming Interface (API). Contact your Agency Lead or Agency Specialist to initiate this process.

# How frequently is the AIS Death Data updated?

Updates occur weekly.

# Where are potential matches against the AIS Death Data displayed?

Payment matches will display in the Payments module of the DNP Portal for adjudication. In the *Payments Matched* section of the page (Sources column), Obituary matches will display as "AIS-OBIT" and Probate matches will display as "AIS-PROB." Agencies who onboard for Online Search, Batch Matching, or Continuous Monitoring will also see matches within these modules.

# How much does the use of the AIS Death Data cost agencies?

The AIS Death Data is available at no cost to agencies enrolled in DNP.

# Will DNP stop a payment if there is a match against the AIS Death Data?

No. DNP does not stop payments. However, using AIS through the Batch Matching and Continuous Monitoring modules would help prevent payments during the pre-award/pre-payment phases of the payment lifecycle.

# What if I don't want to see the AIS matches in the Portal?

Your agency can apply Business Rules or Whitelisting to address these matches. To find out about how Business Rules and Whitelisting can help, please contact your Agency Lead or Agency Specialist.

### What should I do if there is a discrepancy between AIS Death Data and the DMF?

Discrepancies between data sources require due diligence in order to properly adjudicate matches. For example, if an AIS match has a different date of death than the DMF match, your agency must determine which date is the accurate one. Follow the internal processes mandated by your agency.





#### **Frequently Asked Questions**

#### What is the Death Master File?

The Death Master File (DMF) from the Social Security Administration (SSA) is a data source that contains records of deaths reported to SSA. The deaths reported to SSA come from many sources, including family members, funeral homes, financial institutions, postal authorities, state information, and other federal agencies.

There are two versions of the DMF; DMF-Public and DMF-Full. The DMF-Public is provided by the Department of Commerce's National Technical Information Service (NTIS) and does not contain state vital records, while <a href="mailto:the DMF-Full does contain state">the DMF-Full does contain state</a> vital records. It is important to note that the SSA records are not a comprehensive record of all deaths in the country.

#### Does DNP have access to DMF-Full?

As of December 29, 2023, DNP has access to the DMF-Full as a replacement for the DMF-Public. DMF-Full is available in the DNP Portal for Online Search, Batch Matching, Continuous Monitoring, Application Programming Interface (API), and Payment Integration.

### How do I gain access to the DMF-Full data source in the DNP Portal?

Any program that currently has access to DMF-Public in the DNP Portal, will automatically receive access to DMF-Full on December 29, 2023. All other users of the DNP Portal must request access for data source approval.

If your agency disburses funds via the Treasury's Payment Automation Manager (PAM) system, then the PAM file will be matched against the DMF-Full through the DNP Portal during Payment Integration.

#### How did DNP gain access to the DMF-Full?

The Consolidation Appropriations Act, 2021—Title VIII-Access to Death Information Furnished to or Maintained by the SSA— states it provides information furnished to the SSA to the agency operating the DNP working system.

# How much does the DMF-Full in the DNP Portal cost for agencies?

DMF-Full is available at no cost to agencies enrolled in DNP.

# Will DNP stop a payment if there is a match against the DMF-Full in the DNP Portal?

No. DNP does not stop payments; however, contact your Agency Lead or Agency Specialist to discuss how to leverage DNP during the pre-award/pre-payment phases of the payment lifecycle.

### Can the DMF-Full file be downloaded from the DNP Portal?

No. You cannot download the DMF-Full file from the DNP Portal. Matches against the DMF-Full are displayed in the DNP Portal; however, matched records may be downloaded via an Excel spreadsheet.

### How frequently is the DMF-Full updated within the DNP Portal?

Updates for the DMF occur on a weekly basis. A full refresh of the data occurs annually. To verify when the latest update is made to the DMF-Full in the Portal, you can hover your cursor over the name of the data source.

Also, additional matches for the same payment will give further insight for follow-up.

## How do I gain access to the DOD Death Data?

Payments submitted to DNP via the Payment Automation Manager (PAM) are automatically vetted against the DOD Death Data. DOD Death Data is available to all users in Payments, but requires onboarding for Online Search, Batch Matching, Continuous Monitoring, Application Programming Interface (API). Contact your Agency Lead or Agency Specialist to initiate this process.





Payments submitted to DNP via the Payment Automation Manager (PAM) are automatically vetted against the DOS Death Data. 



#### **Frequently Asked Questions**

### What is the Electronic Verification of Vital Events Fact of Death?

The Electronic Verification of Vital Events Fact of Death (EVVE FOD) is a data service from the National Association for Public Health Statistics and Information Systems (NAPHSIS). It contains information to verify identities by matching against death record databases of vital records offices in participating jurisdictions.

#### **Protecting Identity**

Vital records offices register births and deaths and issue certified copies of birth and death certificates for legal and administrative purposes. At some point, each of us will need to use a birth certificate to prove our identity. Vital records offices provide these legal documents to you through a careful and secure process that helps prevent identity theft and other fraudulent acts.

# How does DNP help my agency with this data service?

The EVVE FOD data service is available in the Do Not Pay (DNP) Portal for Online Search functionality. By verifying eligibility prior to awarding a grant or issuing a payment, you will help your agency reduce these types of improper payments.

#### Is there a cost for using EVVE FOD?

No. EVVE FOD is available at no cost to agencies enrolled in DNP.

## How do I gain access to EVVE FOD in the DNP Portal?

Agencies must apply and be approved to access EVVE FOD in the DNP Portal. Contact your Agency Lead or Agency Specialist for more information.

### What does a match against the EVVE FOD data source mean?

A match against EVVE FOD means a death certificate is on file with the reporting jurisdiction.

# Will EVVE FOD provide a copy of a match death certificate?

No. Matches against EVVE FOD confirms a death certificate is on file but does not display the death certificate.

# Will DNP stop a payment if there is an EVVE FOD confirmation?

No. DNP does not stop payments. However, using EVVE FOD through Online Search would help prevent payments during the pre-award/pre-payment phases of the payment lifecycle.

# Which states do not have death record information in EVVE FOD?

The states that currently do not have death record information in EVVE FOD are Hawaii, Virginia, New Jersey, New Hampshire, New York, North Carolina, Pennsylvania, and Texas. All other states are participating jurisdictions (including Washington DC and Puerto Rico).

### For which module is EVVE FOD available in the DNP Portal?

The EVVE FOD data service is available in Online Search.

# Why is there a delay with EVVE FOD match results returning in the DNP Portal?

Because the EVVE FOD comprises of many different participating jurisdictions, a search may take up to ten seconds or more to display match results.

# What should I do if there is a discrepancy between EVVE FOD data and other DNP Death data sources?

Discrepancies between data sources require due diligence in order to properly adjudicate matches. For example, if EVVE FOD information has a different date of death than the Death Master File (DMF) or any of the other death data sources available in the DNP Portal, your agency must determine which date is the accurate one. Follow the internal processes mandated by your agency.

# What does the "Jurisdictions unavailable" box in the Match Results page mean?

One or more participating jurisdictions may be unavailable at the time of your search. You may want to perform the search at a later time when these jurisdictions become available in order to have a more accurate search result.



# What kind of information does a match in the DNP Portal return?

When conducting searches, the DNP Portal returns the data elements listed in the data element chart.

#### What is the "updated on" date?

EVVE FOD data is updated on an ongoing basis as participating states and jurisdictions provide updates. DNP will provide the most up-to-date data from EVVE FOD.
