Safeguarding PII

The loss of PII can result in substantial harm to individuals, including identity theft or other fraudulent use of the information.

Safeguarding PII is a top priority for DNP.



Be Aware!

How is PII Accidentally Transmitted?

- 1. Emailing screenshots due to questions about the data in the DNP Portal
- 2. Forwarding internal emails
- Emailing data files (This includes passwordprotected emails)
- 4. Sending PII that has not been properly redacted



Be Aware! Forwarding Emails

Most agencies have secure firewalls that protect PII within intra-agency communications.

Any email is exposed to risk when sent via an unsecure route to the DNP.

Forwarded emails have a greater risk of containing PII of which the sender is unaware.



Be Aware! Data Files

Password-protected encryption fails to reduce risk when emailing PII.

The only acceptable way to send data files containing PII is through an established DNP secure transfer method.





Be Aware! Removable Redaction
