RITS Bulk File Layout

Bulk File Format Conventions

The following conventions were used in the bulk file formats for this document.

- All required fields are indicated by a •
- Values in the column "Type" \circ A Alphanumeric \circ N Numeric
- Alphanumeric fields are left justified and padded with spaces.
- Numeric fields are right justified and padded with zeros.
- Numeric fields with an implied decimal are described in the "Lengths" column as two numbers separated by a decimal.
 - o The first number represents the total length of the field.
 - o The second number represents the implied decimal places within the field.
 - For example, a numeric field defined as 11.2 has a total of 11 bytes with 2 implied decimal places.
- Standard or valid default value(s) of fields are denoted by quotes ("xxxxxx") around the value.

Bulk File Processing Constraints

The recommended file size recommended for all IPAC bulk files is less than 30mb; however, there are other file processing factors that could contribute to "application exception" errors. This includes the number of transaction types in a single file, transaction errors, multiple bulk files submitted at the same time and other agency files processing at the same time. It is recommended file submissions be staggered and not submit a larger number of files at the same time.

SF 2812 Data

Purpose:

The data elements reflect a line-by-line listing of the data elements for the developmental Retirement and Insurance Transfer System (RITS).

Each 2812 and 2812A are viewed as one transaction containing multiple record types. The SF2812 Data will require three records, the number of records necessary for the SF 2812A.

Overstrike Codes

The last character of the field contained a letter instead of a digit, which is an Overstrike Code. This is used to code positive/credit, negative/debit values in the amount field.

* The last digit of the amount field is "signed" with an over-punch to indicate a positive or negative dollar amount.

Example: "N" translates to a negative "5."
